ANTIRAGGING POLICY

INTRODUCTION

Ragging is a criminal offence and it is strictly prohibited by both State Govt. and Central Govt. The Punishment for ragging will be as follows:

THE PUNISHMENT FOR RAGGING

- Imprisonment up to three years and fine of Rs.75,000/-
- Dismissal from the college

OBJECTIVES

- To prohibit, prevent and eliminate the ragging including any conduct by any student whether by words spoken or written or by an act which has the effect of teasing, treating or handling a fresher with rudeness or any other student or indulging in undisciplined activities by any student.
- To monitor, direct and oversee the functions and performance of the Anti-Ragging Squads in prevention and curbing of ragging in the institution.
- The Anti-Ragging Committee of the institution shall take an appropriate decision with regard to punishment or otherwise depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.

RESPONSIBILITIES

- To be vigilant at all hours and all around the campus to oversee ragging and shall be empowered to inspect such places.
- Anti-Ragging Committee to ensure compliance with the provisions of regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.

ANTIRAGGING POLICY

- To make surprise raids on hostels and other places vulnerable to incidents and having the potential for ragging.
- To conduct an on-the-spot enquiry into any incident of ragging referred to it by the faculty or student or parent or guardian and the enquiry report along with recommendations shall be submitted to the Head of the Institution for action.
- To ensure the display of posters on Institution and Department Notice Boards and other prominent designated places.
- > To offer services of counseling and create awareness to the students.
