- ➤ Only conduct research involving animals after receiving approval from an appropriate animal ethics review body.

ETHICS FOR PLAGIARISM CHECK

- ➤ The college wants to raise awareness among its staff and students about acceptable research, study, project, assignment, thesis, and dissertation behavior as well as the avoidance of misconduct, including plagiarism.
- > The college wants to create tools to identify plagiarism and put in place safeguards against it.
- > The college checks for plagiarism using well-known programs like other web resources.
