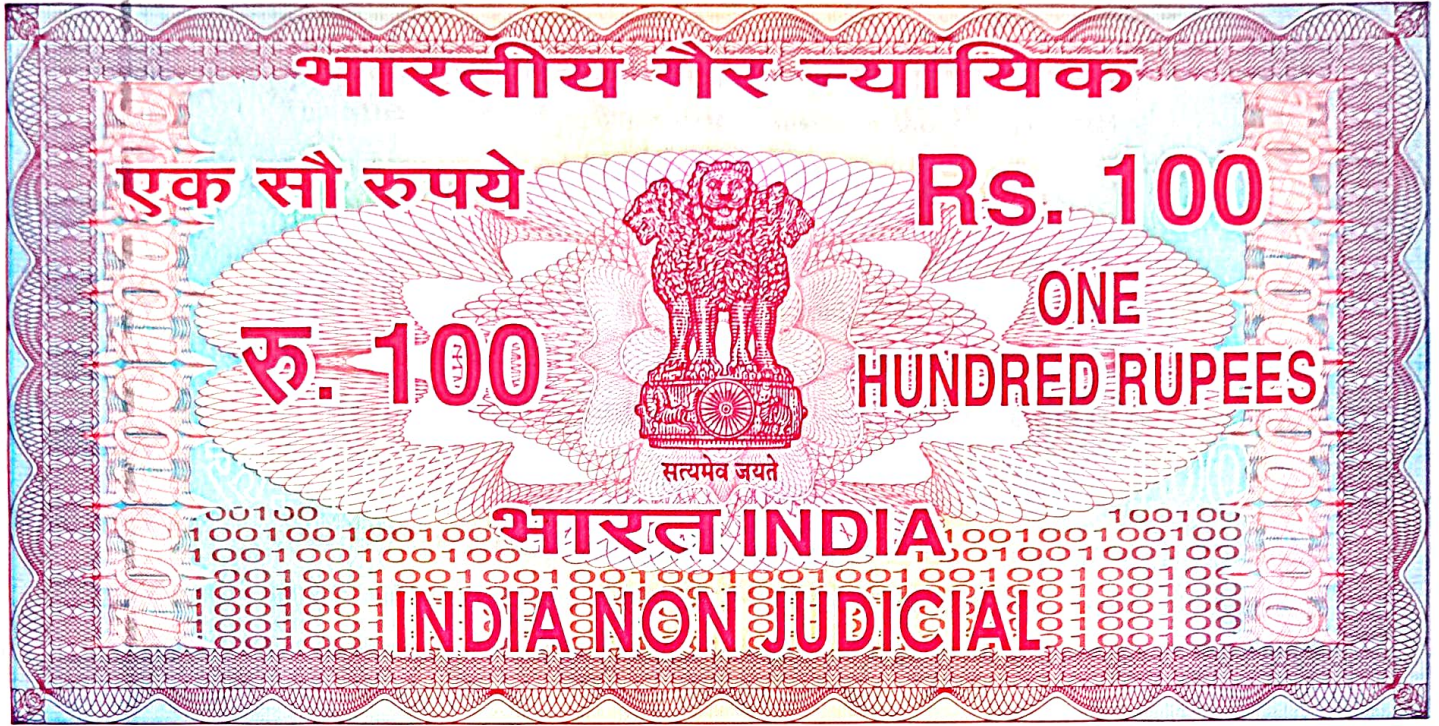

shall have equal right to patent the development with due acknowledgement of other party's contribution. Commercial exploitation if any shall be shared proportionally with mutual agreement.



MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (herein after called as the 'MOU') is entered into on this the 18th day of December Month 2023 (Date 18-12-2023) by and between **ExcelR Edtech Pvt. Ltd.**,
(Here in after referred as '**First Party**')

And

(Here in after referred to as '**Second Party**')

(First Party and Second Party are hereinafter jointly referred to as '**Parties**' and individually as '**Party**')

WHEREAS:

1. First Party is a EdTech company: ExcelR Edtech Pvt. Ltd.
2. First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
3. The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
4. Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

11. Training & Development and dissemination of knowledge for students of second party & affiliated colleges and employees of both the organizations.

12. ExcelR would work with incubation centers/ innovation cells of second party (Case to case basis), to formulate the business cases and data collection process from various industry and academic bodies that are associated with the second party.
13. Cooperation between both parties would be extended to any other area which may be mutually beneficial to both the organizations.

CLAUSE 2: SCOPE OF THE MoU

14. The budding graduates from the institutions could play a key role in technological up-gradation, innovation, and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
15. Software Technologies Training: The first party will provide the trainings to the students and Faculties of the second party on different technologies like Data Science, Data Analyst, Artificial Intelligence, Tableau, Python, etc., Research and Development
16. Skill Development Programs: First Party to train the students of second Party on the emerging technologies to bridge the skill gap and make them industry ready.

18. Faculty Development Programs: First Party to train the faculties of second Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
19. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein.

CLAUSE 4: VALIDITY

25. The period of the agreement is valid for a period of 2 years from the date of signing of this agreement.
26. This agreement will be valid only at the intentions of the parties involved therein, this MOU could be dissolved or cancelled by either party any time by giving 30 days' notice and shall not have any legal bindings in nature should either or all the parties to it opt to not act upon, the MOU loses its validity.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

27. It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on this **03rd June 2024** between M/s Linways Technologies Pvt. Ltd, Integrated Startup Complex HMT Colony, North Kalamassery, Kalamassery, Ernakulam, Kerala 683503 represented by **Mr. Bastin Thomas, Managing Director of M/s Linways Technologies Pvt Ltd** (Here in after called "The First Party") and **Dhaanish Ahmed Institute of Technology, Dhaanish Avenue, Verappanur, Kandhe Gounden Chavadi, Tamil Nadu 641105** represented by **Principal, Dhaanish Ahmed Institute of Technology, Dhaanish Avenue, Verappanur, Kandhe Gounden Chavadi, Tamil Nadu 641105** (Hereafter called "The Second Party"). Both "The First Party" and "The Second Party" are collectively called "The Parties". Both "The First Party" and "The Second Party" can individually be called "The Party".

WHEREAS the First Party is engaged in the business of providing services of Academic Management System and is willing to offer the said service to the Second Party on a yearly basis on mutually agreeable terms and conditions.

AND WHEREAS the Second Party is the service receiver as per this MoU, is willing to accept the service provided by the First Party on a yearly basis on the basis of suitable consideration as fixed by the First Party and as per the terms and conditions set forth by both the parties in the MoU.

Accordingly, the Parties desire to create a framework on which to proceed with and to diligently pursue the activities they mutually agree and to implement it in a manner consistent with the terms set forth in this MoU.



NOW, THEREFORE, in recognition of agreement in principle, the Parties record their understanding as follows:

1) The First Party will provide Academic Management Services to the Second Party at an annual rate of INR 1,50,000 (One lakh fifty thousand rupees only) for a student capacity of up to 1000, inclusive of any taxes required by the Government of India or its relevant tax authorities. For a capacity of up to 1200 students, the First Party will charge INR 159,300, inclusive of any applicable taxes mandated by the Government of India or its relevant tax authorities.

The First Party will provide the following modules or facilities as part of Academic Management Services to the Second Party:

2) During the validity period of this MoU, the First Party should provide necessary remote application support to the Second Party with regard to the services provided by the First Party to the Second Party.

3) The modes of communication for the technical support as mentioned in the clause 2 above will be through Telephone, E-Mails, and Internet chatting.

4) The application support as mentioned in the clause 3 above will be available on working days Monday to Saturday on 9:00 am to 6:00 Pm basis during the validity of this MoU.

5) No Party shall disclose any information to any third party concerning the matters under this MoU. Any information, whether proprietary or not, to be contained in reports or disclosed by one Party to the other Party, shall be kept strictly confidential by the receiving Party and shall not be disclosed to any third party without the prior written consent of the original disclosing party. This obligation is of binding nature and shall survive the termination or expiration of this MoU.

6) The Second Party will pay for the above mentioned services at the rate mentioned in Point No. 1 on Quarterly basis, before the 15th day of the first month of each quarter. The payment for the initial quarter should be made in advance. All payments shall be made through online transactions. The First Party can and has the right to terminate the said service provided to the Second Party within 45 calendar days from the due date of payment, in case of default made by the Second Party in payment of quarterly payment of service charges. The First Party will send a payment reminder notification 30 days in advance.

7) The validity period of this MoU will be up to **31st May 2026** The MoU can also be terminated by the mutual consent of both the Parties before the expiry of the validity period of this MoU. The MoU can be renewed with the mutual consent of both the Parties at any point in time within the validity period of this MoU or after the validity period of this MoU.



8) No Party shall have the right or power to bind any other party to any clauses of MoU without the prior written consent of the other Party, except clause 6. The Parties do not intend merely by this MoU to create a partnership, corporation or an entity accessible or taxable under any law of the country.



